- > Process for Review and Approval of Fieldwork: Review of Document Drafts
  - RB advised that the fieldwork protocols are ready for JOHSC & SRS to review
  - BL and A-MD are developing a Fieldwork Guide to accompany the forms as a resource. BL is on the URGE Committee and they will be adding a section on field safety for BIPOC.
- > Discussion of Risk Assessment and First Aid Training for Field Courses
  - RB advised that the two Geology field schools are now virtual. The Hydrogeology field school was originally approved to be face-to-face but there was a miscommunication which resulted in the field school being both face-to-face and online. 2/3 of the students will be in person but 1/3 will be online only.
